

Brief Description of Proposed Action: This project proposes to convert the upper 11 stories of this 15 story concrete and masonry structure, presently used primarily for office space with some commercial/ retail space into residential dwelling units. The floors to be converted would be floors 4-12 and 14-15, there is no 13th floor. The commercial space will continue its present use. 154 residential units would be created of between 450-1,295 sq.ft., with the units being a mix of 44 studios, 88 one bedroom, and 22 two (2) bedroom units. The conversion would occur on a floor by floor basis working around existing lease expirations, with the conversion to be substantially complete not later than 2021.
